LINKAGE AGREEMENT

This Linkage Agreement is entered into as of 5th June 2022 between the Department of Economics at Sree Sankara Vidyapeetom College and the Department of Economics at DB Pamba College, collectively referred to as the "Parties" and individually as a "Party."

WHEREAS:

NOW, THEREFORE, the Parties agree as follows:

Purpose of Linkage:

The purpose of this Agreement is to establish a linkage between the Department of Economics at Sree Sankara Vidyapeetom College and the Department of Economics at DB Pamba College to foster collaboration and cooperation in the following areas:

a. Faculty and Student Exchange: Promote the exchange of faculty members and students between the two institutions, allowing them to benefit from diverse academic environments and gain exposure to different teaching and learning methodologies.

Roles and Responsibilities:

b. Department of Economics, DB Pamba College:

Coordinate and facilitate the exchange of faculty members and students with Sree Sankara Vidyapeetom College.

Collaborate with Sree Sankara Vidyapeetom College on joint research projects, case studies, and publications.

Organize and participate in joint workshops, seminars, and conferences.

Share academic resources that can benefit the Department of Economics at Sree Sankara Vidyapeetom College.

Duration:

This Agreement shall be valid for a period of one year from 5th June 2022. Upon expiration, the Agreement may be renewed upon mutual agreement of the Parties.

Confidentiality:

Both Parties shall maintain the confidentiality of any proprietary or sensitive information shared during the collaboration. No Party shall disclose such information to any third party without prior written consent from the other Party.

Termination:

Either Party may terminate this Agreement by providing written notice to the other Party at least 30 days in advance. Termination shall not affect any ongoing collaborations or obligations incurred prior to the termination date.

Governing Law and Dispute Resolution:

Any disputes arising out of or in connection with this Agreement shall be resolved amicably through negotiations between the Parties. If a mutual resolution cannot be achieved, the Parties agree to submit the dispute to mediation or arbitration as per the laws of the applicable jurisdiction.

Entire Agreement:

This Agreement constitutes the entire agreement between the Parties and supersedes any prior agreements or understandings, whether written or oral, relating to the subject matter hereof.
